Dear Edgewater Homeowner,

In accordance with the Bylaws of the Edgewater Condominium Association, Inc., the Annual Members' Meeting will be held on Saturday, December 3, 2022 at 9:00 AM in the Edgewater Residents' Clubhouse. The official meeting notice will be mailed to all homeowners approximately 30 days prior to the meeting date.

The primary purpose of this Members' Meeting is to conduct Association business and to announce the results of the election for two (2) members to serve on the Board of Directors due to the term expirations of Harry Simonini, and David VandeLinde.

Regarding Board of Directors' membership:

- Nominees must be owners in good standing, i.e. current in all dues, fines, and assessments as of November 1 (the official date of record).
- Nominees must be willing to travel to/or participate in Board meetings at a minimum of 3 – 5 times per year.
- Nominees must be willing to serve a two-year term.
- Nominees must not have been relieved of a previously held HOA Board seat.
- Nominees may not serve on more than three HOA Boards at any given time.
- Nominees must be in compliance with Edgewater Rules and Regulations.
- Nominees may not have their Edgewater property listed for sale or in foreclosure.
- Nominees must have at least one year of ownership, as of the date of record (November 1).

The Board of Directors, in accordance with section 5.1 of the Association Bylaws, has appointed a Nominating Committee, Chaired by Roger Life (unit 345).

Nomination for election to the Board of Directors shall be made by the Nominating Committee.
